

## **Liquid-Plumr® Plumr Pipe Puzzler Instant Win Game Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. Eligibility:** Liquid-Plumr Pipe Puzzler Instant Win Game (the "Instant Win Game") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees, officers, and representatives of The Clorox Company ("Sponsor"), Current Lifestyle Marketing, HelloWorld Inc. ("Administrator"), as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Instant Win Game is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. **3. Timing:** The Instant Win Game begins on January 15, 2015 at 12:01 p.m. Pacific Time ("PT") and ends on April 1, 2015 at 12:00 p.m. PT (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Instant Win Game.

**4. How to Enter:** During the Promotion Period, visit [liquidplumr.com/playwithplumrs](http://liquidplumr.com/playwithplumrs) and play the Liquid-Plumr Pipe Puzzler Game (herein, the "Game"). Once you have attempted the Game or completed the last level of the Game, follow the links and instructions to complete and submit the registration form, including your name and a valid email address. Once you submit the form, the Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided instructions for the win and eligibility verification process. All potential winners are subject to verification before any prize will be awarded. Sponsor is responsible for the functionality of the Instant Win Game.

**Limit:** You may play the Pipe Puzzler game as many times per day as you would like but you will only receive one (1) play of the Instant Win game each twenty-four (24) hour period during the Promotion Period. As outlined in Section 8 below, you may only win up to one (1) Instant Win prize during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of plays by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's plays and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the email address used to register will be deemed to be the entrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider, Internet service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

**5. Sweepstakes:** By playing this Instant Win Game, you will have the opportunity to enter into the Liquid-Plumr Grand Prize Finale Sweepstakes. The Sweepstakes is subject to its own Official Rules, found at [liquidplumr.com/playwithplumrs](http://liquidplumr.com/playwithplumrs).

**6. All potential WINNING PLAYS ARE SUBJECT TO VERIFICATION BY SPONSOR, WHOSE DECISIONS ARE FINAL AND BINDING. **7. Instant Win Game Prize Selection and Verification of Potential Winners:** Receiving a prize is contingent upon compliance with these Official Rules. Sponsor's decisions as to the administration and operation of the Instant Win Game and the selection of potential winners are final and binding in all matters related to the Instant Win Game. There will be three (3) random, computer-generated winning times during each calendar day of the Promotion Period. There will be a total of two hundred thirty-one (231) prizes awarded during the Promotion Period. If you are the first player to play the Instant Win Game at or after one of the randomly-generated times, you will be a potential instant winner of the prize. If you receive an on-screen message that you have won an instant win prize, you will receive an email at the email address provided in the submission process within ten (10) days requesting that you provide a mailing address (no P.O. Release:** By entering, entrants agree to release and hold harmless Sponsor, Current Lifestyle Marketing, Administrator, and any promotional partners, each of their parent, subsidiary, affiliate, and related companies, and each of its and their respective officers, directors, employees, and agents (collectively the "Released Parties") from and against any losses, damages, rights, claim, or cause of action of any kind arising, in whole or in part, directly or indirectly, out of participation in the Instant Win Game or resulting directly or indirectly, from acceptance, possession, use, or misuse of any prize awarded in connection with the Instant Win Game, including without limitation personal injury, death, and/or property damage, as well as claims based on publicity rights, defamation, and/or invasion of privacy.

Disputes:** Entrant agrees that: (i) any and all disputes, claims, and causes of action arising out of or connected with this Instant Win Game or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (ii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Instant Win Game but in no event attorneys' fees; and (iii) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental, and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
